- 4. List of members of Anti Ragging Committee must be displayed on each and every notice board of building of respective schools and hostel with contact details.
- 5. Students can register their complaint offline by submitting application to anti ragging member of respective school.
- 6. Students can register their complaint online by mailing on antiraggingcell@ppsu.ac.in.
- 7. Awareness about Ragging and related Punishment given during Orientation Program of respective schools.
- 8. There is no case regarding ragging of student.
